Introduction

Anew Establishment Corp DBA J & M Cleaning Team (also referred to below as “we,” “us” and “our”) is a privacy conscious organization. This privacy statement explains how we protect visitors’ information gathered via the Web pages of the jmcleaningteam.com website. By using the J & M Cleaning Team Website you agree to the use of such information in accordance with this privacy statement.

Information collection

As a visitor, you do not have to submit any personal information in order to use the website. The J & M Cleaning Team Website collects personal information only if it is specifically and voluntarily provided by visitors. Such information may consist of, but is not limited to, your name, current job title, company address, email address and telephone and fax numbers.

Information use

In such cases, the information you submit may be used to manage your request; to manage our relationship with you; or to customize or improve the J & M Cleaning Team Website.

We may also use your personal information for marketing purposes, or to send you promotional materials or communications regarding services provided by us or other members of the J & M Cleaning Team Network that we feel may be of interest to you. We may also contact you to seek feedback on our services or for market or other research purposes. Your personal information may also be used to protect our rights or property and that of our users.

You may at any time request that we discontinue sending you emails or other communications generated in response to your registration on the J & M Cleaning Team Website.

Disclosure of information to third parties

We may provide your personal information to other members of the J & M Cleaning Team Network in order to provide you with information that could be of interest to you and conduct market or other research. Personal information may also be disclosed to members of the J & M Cleaning Team Network and other third parties in order to respond to your requests or inquiries; as part of a corporate transaction (such as a sale, divestiture, merger or acquisition); or where those parties handle information on our behalf.

All of these disclosures may involve the transfer of personal information to countries or regions without data protection rules similar to those in effect in your area of residence.

Personal information may also be disclosed to law enforcement, regulatory or other government agencies, or to other third parties, in each case to comply with legal or regulatory obligations or requests.
